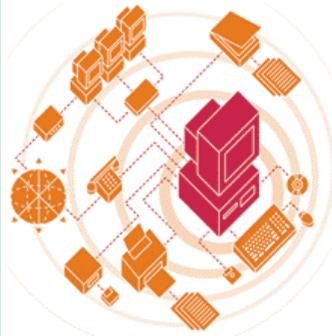

Your IT Strategy for 2008

Today's IT executives are focused on building a reputation for providing value to their business. A cornerstone for achieving that goal is a well-articulated IT strategy. So what is a strategy, really? And furthermore what is an IT strategy?

According to Michael Porter, foremost management guru, strategy is "a broad based formula for how business is going to compete, what its goals should be, and what will be needed to carry out those goals. The essence of formulating competitive strategy is relating a company to its environment". As for IT strategy, it is NOT simply about the number of computers the company needs to buy, nor is it the types of software or the IT skills that need to be recruited. An IT strategy must, at the very least, describe the alignment of business plans and IT architecture.

To achieve a successful IT strategy, companies should take part in a consultative process involving management, employees and shareholders. This way, a company can establish a companywide IT Vision, IT mission, strategic objectives and business



performance measures. This type of process allows companies to create IT programmes that support business goals such as "rapid development of new products or services" and "streamlining business processes". There are many IT related decisions to be made, with respect to applications, infrastructure, the web or its management. These must be made taking into consideration the business implications to the company. For instance the decision to purchase off-the-shelf instead of using custom applications. To arrive at these maxims and principles, decision-makers must have a clear idea of the company's internal strengths and weaknesses, and the opportunities and threats from the external environment.

Information technology has become a modern phenomenon and is indispensable to today's business practices. The formulation of an IT strategy has become as crucial as the production of financial statements. A strategy will help companies make the best use of their IT resources now and in the future. It will help ensure that the purchase, use and management of technology are firmly tied to the company's vision and business objectives.

CustomsAid. This year we worked closely with the Customs Department to develop the new system which allows brokers to submit their entries online, thereby reducing the time it takes to clear goods. We are very grateful to the management and staff at Hobson Enterprises who spent a lot of time testing the software. We launched CustomsAid 5.1 in **September** with the online submission feature and many other enhancements. A number of our clients have come on board and are very excited about these benefits.

We also had a soft launch of the **Pay-As-You-Use** version of CustomsAid targeted at brokers and companies who produce entries infrequently and who cannot meet the upfront expense of purchasing CustomsAid.

WagesPlus. This year, Leyton enhanced WagesPlus, our payroll system to make several new optional features available. Leyton now has the ability to install employee clocks for our customers, which relieves companies from entering employee time manually and thus saves time and money. Computer Tip – Protecting Your Eyes

In today's world, we spend many hours a day working in front of a computer. If you are suffering from eye problems and headaches, pain in the shoulder, neck or back, this could be caused by computer use. Take these steps to protect your eyes:

- Have your eyes examined annually. If you wear glasses, consider glare coating on your lenses.
- Select a monitor with a larger and flat screen.
- Place your screen 20 to 26 inches away from your eyes and the top of the screen at or a little below eye level. So you can read the screen without leaning your head, neck, or trunk forward or backward.
- To reduce glare, place your monitor perpendicular to a window, adjust or add window blinds, and reduce interior lighting to lower glare and reflections.
- Take a vision break every 20 minutes or so and look at an object 20 feet away to relax your eye muscles.
- Blink your eyes regularly and more often to rewet your eyes and avoid dryness and irritation.
- Alternate your computer work with non-computer tasks to give your eyes a rest.
